Procedure for Submission of Bids

It is proposed to have a Three Bid System for this tender

a. Pre-qualification Bid and EMD of Rs.7,000/-(Refundable) in the form of DD drawn in favour of National Insurance Company Limited payable at Mumbai in one cover (cover-I) appropriately super scribed.



- b. Technical Bid in one cover (Cover-II) appropriately super scribed.
- c. Commercial Bid in one cover (Cover-III) appropriately super scribed.
- 1.1:- The Pre-qualification bid along with above DD should be submitted in a separately sealed cover super scribed as —<u>Tender for UPS Batteries- Prequalification Bid</u>. The cover should be marked as "Original" and also super scribed with Tender Reference Number and the wording —DO NOT OPEN BEFORE 30/08/2019, 03:30 PM. All the eligibility criteria should be as per the Annexure-A and should form the part of Prequalification Bid.
- 1.2:- The Technical Bid should be submitted in a separately sealed cover super scribed —<u>Tender for UPS Batteries</u>
 -<u>Technical Bid</u>. The cover should be marked as "Original" and also super scribed with Tender Reference Number and the wording —DO NOT OPEN BEFORE 30/08/2019, 03:30 PM. All details of the product should be as per the Annexure-B and it should form the part of Technical Bid.
- 1.3:- The Commercial Bid of the Tenderer should be submitted in sealed covers super scribed as —<u>Tender for UPS Batteries Commercial Bid</u>. The covers should be super scribed with Tender Reference Number and the wording —DO NOT OPEN BEFORE 30/08/2019, 03:30 PM. Price for the items should be quoted separately citing unit price and applicable taxes and it should form the part of Annexure-C.
- 1.4:- All the three covers namely Pre-qualification, Technical and Commercial Bids for UPS Batteries, prepared as above, are to be put in a single sealed cover super scribed with —Tender for UPS Batteries—NIC/MBRO-II/IT/2019-20/03 —DO NOT OPEN BEFORE 30/08/2019, 03:30 PM
- 1.4:- The cover thus prepared should also indicate clearly the name and address of the Tenderer, to enable the Bid to be returned unopened in case it is declared "Late".

Please note that EMD shall be kept as security deposit submitted by the successful bidder till completion of warranty period.

TERMS AND CONDITIONS OF THE TENDER

1. Eligibility Criteria:

The vendor must be Original Equipment Manufacturer or an authorised distributor/dealer/partner of the OEM. The documentary proofs like Authorisation letter, GSTN Registration, TAN, PAN number, Details/Documents of Turnover for the previous two years are required to be submitted along with the bid. The offer must be made in Indian Rupees only; all costs should be given in Figures and Words. Prequalification norms of bidders shall be entirely at the discretion of Tender Committee of the Company. Techno commercial bid of the tenderers, who are not selected by the committee in the prequalification stage and Technical Bid stage shall not be opened.

2. Payment Terms:

National Insurance Co. Ltd., will make payment through NEFT/RTGS mode on successful supply & installation of batteries to existing UPS and on submission of duly signed installation report of National official.

- 2.1 For ensuring NEFT/RTGS payment, the service provider would complete all formalities in regard to payment through electronic mode.
- 2.2 The payment would be made after deducting necessary taxes applicable.

3. Delivery and Installation:

- The complete set of items ordered should be delivered and installed within One (1) week from the date of purchase order. If the batteries are not delivered and installed by the mutually agreed date of delivery at the sites mentioned above, National reserves the right to cancel the purchase order.
- Proper Installation reports should be submitted in Division Offices after installation of batteries indicating all necessary voltage parameters of batteries & UPS.
- Purchase/Buyback quantity of batteries may vary depending upon availability/requirement of batteries at respective office. For tender purpose considering replacement of complete set of batteries we are taking count as 40 numbers.

4. Warranty:

Vendor shall provide a minimum of 24 month's comprehensive onsite warranty for batteries from the date of installation of the batteries. During the warranty period, defective battery/ies if any, should be replaced within 48 hours of the reporting. In case of failure of battery/ies the vendor shall ensure that UPS is made operational to the full satisfaction of the office with stand-by provision till the replacement of affected battery/ies.

5. Penalty for Delay:

For any delay in installation and commissioning of the ordered items, NIC Limited will charge penalty @ 0.5% of the order value per week or part thereof.

6. Others:

- (a) No upward revision of price will be acceptable even if any duty structure or tax structure changes or there is fluctuation in foreign exchange rates.
- (b) Vendors will pass on to NIC Limited all fiscal benefits arising out of reductions in Government levies, viz. GST etc.
- (c) No deviation from the specific technical specifications given for the product given in ANNEXURE-B. The bid which deviates from the given technical parameters may be rejected.
- (d) The bids will be opened in the presence of duly authorised representatives of the participated bidders, if they choose to attend at 03:30 PM on 30/08/2019. Representative should carry their ID proof.
- (e) Price for the items should be quoted as per the format in Annexure-C showing price and taxes separately.
- (f) The prices should also include transportation, installation, handling, coolie and any other charges involved up to the installation.
- (g) The vendors are also to quote for the Buyback value of the existing 42 Ah/ 12 V batteries.
