2. MEDICAL CONSULTANTS/SPECIALIST DOCTORS (HEALTH CLAIMS HUB)

- A. Applications are invited from Doctors based in Mumbai and its suburbs with the following profile to work on contract/retainer basis on part time as Medical Consultants:
 - Essential Qualification/Experience: Should have minimum MBBS(Allopathy) degree and work experience of minimum eight years. Those retired from Government service may also apply.
 - Experience of qualified Doctors from Ayurveda/Homoeo system of medicine work experience of handling large Group health program in an Insurance Company/TPA for at least five years
 - Age above 32 years
 - The incumbent will have to spend a minimum of 12-15 hours per week(to be spread over 3-5 days as per convenience); remuneration will be as per the number of cases referred / claims verified / attended.
