Following points were discussed in the meeting with regards to the queries as raised by the participants

Monthly Volume Pattern:

- No fixed monthly volume pattern can be stated since the PMFBY scheme is season based and inference can be made from from **Rabi 2016-17**
- No minimum volume commitment can be given on enrolment of farmers
- The number of loanee farmer may be more than non loanee farmer

Outsourcing to Third Parties:

- Outsourcing is not allowed in general except for specialised and highly skilled activities. The prior permission of NIC is mandatory. The bidder shall be solely responsible for the activities outsourced and the results thereof.

Use of UAV / Drone applications:

- The charges may be specified on the basis of per Sq. Kms with minimum of 10 Sq. kms

Document scanning Charges:

- The bidders should submit the cost of cloud storage with 1) Document Management Systems 2) Without Document Management systems
- The bidders may submit the charges of scanning, relevant indexing and retrieval on cost per page basis for document scanning

GST Rates:

- The bidders may submit their cost excluding GST and column should be marked as 'applicable GST'

Extension of Dates:

- The **Bid Submission date is extended upto 29th November 2017, 3 pm** and opening of the **Technical Bid** will be on the same day at 4 pm.

LD clause:

- 5% of the bid value of each item

Power point Presentation:

- Each **Qualified bidder in Technical Bid** have to make a Power point presentation

Evaluation of Financial capacity of bidder:

- The financial capacity of the Bidder shall be evaluated.
