Sealed Tenders are invited from Kolkata based bonafide, reputed and wellestablished Vendors for empanelment as follows:

IT Equipment, Consumables and Peripherals Suppliers for supply and installation of IT Equipments, Consumables and peripherals as and when required.

Applications for empanelment are to be submitted as per the specimen format enclosed. Bidders willing to apply for empanelment, should submit the application forms with supportive documents.

A. Eligibility Criteria

- Must have Valid Trade Licence issued by appropriate Authority for carrying out the business.
- Bidder should be Authorised Partners of supplied/quoted Brands as and when required.
- Submitted Income Tax Return for the last Assessment year & possess PAN Card.
- 4) Submitted Sales Tax Return.
- 5) GST Registration number at West Bengal with supporting document(s). In case of unregistered GST vendor, declaration should be provided for the same with valid reason.
- 6) Must have average Turnover of ₹1,00,000.00 (Rupees One Lakh) and above for supplying and installing IT Equipment, Consumables and peripherals items during the last 3 (Three) years ending 31-03-2017.
- 7) Earnest Money of ₹5,000.00(Rupees Five Thousand only) in the form of Bank Draft / Pay Order / Bankers' Cheque in favour of "NATIONAL INSURANCE COMPANY LIMITED" payable at Kolkata is to be enclosed separately in an envelope. The Earnest Money of successful Vendors will be kept as Security Deposit up to the validity of the panel and carry no interest. Earnest Money of unsuccessful Vendor will be refunded without any interest after the exercise of empanelment is over.
- 8) Existing Vendors willing to continue as empanelled vendors and having previous Earnest Money deposit still retained by NIC are not required to deposit Earnest Money of ₹5,000.00(Rupees Five Thousand only) but should submit all latest supportive documents.

B. Other information, Terms and Conditions

- 1) Bidder can submit applications for empanelment for items as mentioned in Annexure-A. In few cases of hardware items, brands against the column 'Make" have been mentioned based on our past experience, quality, reliability and availability of the hardware.
- 2) Clearly legible copies of documentary evidence, duly signed and stamped, in support of requirement Nos. 1, 2, 3 & 4 of the eligibility criteria must be submitted.
- Declaration and/or information and/or copies of documents, to be submitted, should have consistency with the nature of Trade or Business.
- 4) If any information/documents furnished/submitted by any Bidder are found to be incorrect or false, the application for such Bidder will be straightaway rejected.
- 5) The Company reserve the right to inspect the premises of the Vendors and/or ask for original documents (the copies of which have been submitted with the application) for verification as and when asked by the Company. The Company may ask for further information/documents, if necessary.
- 6) The empanelment shall be for a period of **02 (two)** years from 01-04-2018 or any other date as may be decided by the Company. However, after completion of one year the panel will be revised. The empanelment may be further extended or reduced depending on necessity/performance and at the sole discretion of the Company.
- Quotations will be invited from the empanelled Vendors for procuring items/getting service under concerned group mentioned in Annexure-A and L1 will awarded the order.
- 8) The empanelled Vendors shall be liable to supply and install currently manufactured items within the stipulated time.
- Delay in supply of items beyond stipulated time may lead to cancellation of order.
- 10) During the mid-period, on review, if the service of any of the empanelled Vendor/s is/are found to be unsatisfactory, the name of such Vendor/s shall be deleted from the panel and will be barred from participation in next vendor empanelment exercise.
- 11) The Company reserves the right to de-panel a Vendor in the following situation:
 - i) Non-participation in 50% of the Tender in a year.
 - ii) Inability to supply and install items/to provide service as per specifications and on quoted rate within stipulated time.
 - During the tenure if any vendor is observed to have supply of duplicate/incompatible/spurious cartridge or counterfeit/substandard products.
- 12) Bid without Earnest Money Deposit shall be out rightly rejected.

- 13) The selected Vendor may at their option, withdraw name from the panel by giving 30 (Thirty) days notice in writing. The Company may also de-panel a Vendor by giving 30 (Thirty) days notice in writing without assigning any reason whatsoever.
- 14) Conditional Bid shall be straightaway rejected.
- 15) Bid submitted after the specified date and time shall not be accepted.
- 16) Company reserves absolute right to accept or reject any or all the Bids without assigning any reason whatsoever.
- 17) NIC invites RATE CONTRACT for all the IT equipment as listed in the attached annexure (Annexure-A) to be valid for 6 months.
- 18) All the vendors should be preferably GST registered.
- 19) If any existing empanelled vendor is found to be having unsatisfactory performance in the last 2 years with NIC, those vendors may be not considered for this empanelment exercise.
- 20) Separate group of vendors may be formed for stock transfer of IT Equipment among NIC offices PAN India.
- 21) Interested bidders for empanelment of stock transfer of IT Equipment among NIC offices PAN India should fill the respective application (Application-2) and submit their bid accordingly.
- 22) Bidders interested to be part of both the empanelment should submit both the applications (Application-1 and Application-2) separately.
- 23) Empanelment of vendors will be separate against Application-1 and Application-2.
