THE TENDERER SHOULD FULFIL ALL THE FOLLOWING CONDITIONS TO BE ELIGIBLE FOR PARTICIPATION IN THE TENDER

1. The Tenderer shall be Authorized Dealer or Bonafied Manufacturer of reputed brand of ACs and should have a fully functional service centre in Kolkata as on date with spares stock for attending breakdown calls. Details of the service centre must be provided.
2. In case of manufacturer, it must possess an experience of **three** years of manufacturing reputed brand of ACs. In case of authorized dealer, it must be dealer of the said reputed Brand for at least **three** years and should be valid as on date.
3. Tenderer should have completed at least three similar type of work or order satisfactorily with State/Central Government Organization or PSUs as on March 31st, 2017. (Necessary document to be enclosed with the Technical Bid).
4. The Tenderer should be free from all encumbrance and there shall no Vigilance case/ CBI Case/ Court Case pending against him and also should not be black listed by any Govt./Semi-Govt./Private institution/PSU. (Annexure – “B” to be enclosed with Technical Bid).

INSTRUCTIONS TO THE TENDERERS

1. **Scope of Work:**

- a) Supply of 5 Star Inverter Type Split AC, 3 Star Non- Inverter type Window and Split AC as per the specification given in the **Technical Bid (Annexure “A”; Part –I and II)**.
- b) Installation of ACs at the designated / earmarked place.
- c) The work shall include supply of all the auxiliary items related to installation of ACs such as MS Stand for outdoor unit, Copper pipe, wire and other fitting materials but will not be restricted to the same and may include any additional items that are necessary for such installation.
- d) The work shall include carriage, loading, unloading, transportation, all labour works related with supply and installation of the ACs.

2. **Submission of Tender:** The Tender shall be submitted in two separate sealed envelopes i.e Envelope No.1 ‘Technical Bid’ and Envelope No.2 ‘Financial Bid.’ The sealed envelope containing Technical bid should be super scribed as “**Technical Bid**” and the sealed envelope containing financial bid should be super scribed as “**Financial Bid**” respectively. The two sealed envelopes, one containing Technical Bid and second containing Financial Bid should be placed in a single envelope No.3, duly sealed and superscribed on the outside with the narration “**Tender for Supply and Installation of Air Conditioners**”.
